TNT expands its Vietnam road network service

EXPRESS delivery services provider, TNT has expanded its Asia Road Network into Vietnam following a further EUR6 million (US\$8.11 million) infusion, bringing the total investment to date to EUR8 million.

The company's road network currently spans Singapore, Malaysia, Thailand and Indochina, and there are plans to link the network to include China through the northeastern border of Vietnam by the end of 2007. Once completed, the network will link over 120 cities across 4,000 kilometres, to cover almost 60 per cent of the region.

First introduced at the end of 2005, TNT's Asia road network is designed to provide a day-definite, door-to-door transport service throughout Asia that works by equipping TNT's container trucks with global positioning satellite (GPS) technology

to track their movements in real-time across the road network, a company statement said

This has resulted in double-digit growth in cargo volumes within a year, the company said. TNT also said road service is two to three times faster than sea freight.

The expansion of TNT's road network into Vietnam comes amid forecasts that the nation will achieve an economic growth rate of eight per cent in 2007-08. Boosted by its WTO accession, foreign direct investment in Vietnam rose by almost 40 per cent to reach US\$10.2 billion in 2006.

"TNT's expansion into the sub-Mekong area is logical given the rapid growth of the region, in particular Vietnam," said Onno Boots, regional managing director of TNT Southeast Asia. "We are now focusing on building extensive networks to strengthen Asia's connectivity, both within the region and to Europe. We will also continue investing in the development of innovative solutions to complement the Asia Road Network and meet our customers' business needs in the region."

TNT's expansion of its road network service into Vietnam is in line with the company's strategic intent to expand its presence in Asia, particularly in key emerging markets. Recent moves include the acquisition of China's Hoau, the purchase of India's Speedage and the construction of a dedicated facility for life sciences in Singapore. This forms part of TNT's overall objective to achieve a global revenue target growth of 10 to 15 per cent in 2007 in its express division.

Fuzhou attracts new SE Asia box service

AMERICAN President Line (APL) together with Mitsui OSK Lines (MOL) has launched a new weekly container shipping service that links Fuzhou International Container Terminal (FICT) to Southeast Asia, reports Xinhua news agency.

The port rotation is: Ho Chi Minh City, Hong Kong, Chiwan, Fuzhou Qingzhou Container Terminal, FICT, Hong Kong, and then back to Ho Chi Minh City.

FICT is scheduled to take delivery this month of two new quay cranes and five new gantry cranes as a third berth will be commencing operations in the second half of this year. This will bring the total number of gantry cranes at FICT to 17 and super post-panamax quay cranes to seven.



Maersk launches Constanza, Romania-China service

MAERSK has inaugurated a new container shipping service from the Romanian port of Constanza on the Black Sea to China.

Management said it has decided to launch the new container shipping service in a bid to tap into growth opportunities amid forecasts that trade between Eastern Europe and China will grow at a rate of 15 to 20 per cent in the coming few years, reports Xinhua.

The service will deploy eight 5,000-TEU containerships equipped with 550 reefer slots. It is hoped the service will turn the port of Constanza into an important hub for Europe-Asia trade in the Black Sea region, the report added.



ICTSI sees Q1 earnings grow 36pc to US\$10.8m

PHILIPPINES-BASED International Container Terminal Services, Inc (ICTSI) has seen its first quarter profit of the 2007 calendar year grow by 36 per cent year on year to US\$10.8 million.

The terminal operator registered a 16 per cent increase in consolidated gross revenues, amounting to \$66.16 million. This was largely due the strong performance of its overseas operations that account for 55 per cent of consolidated net income and are expected to continue to be a significant contributor to earnings.

In a disclosure to the Philippine Stock Exchange, ICTSI said: "The revenue growth was driven mainly by the strong volume growth reported by its operations in Manila,

Poland, Brazil and Madagascar. Revenues from port operations, net of port authorities' share in the first quarter were 20 per cent higher compared to the same period in 2006".

ICTSI has recently expanded its foreign operations with a 20-year concession to operate a cargo terminal in Ecuador and the acquisition of a 60 per cent equity interest in the Yantai Gangtong Container Terminal Co. Ltd. in China, reports AHN Media Corp. The company currently operates terminals at ports in Manila, Poland, Brazil, Madagascar, Indonesia, Japan and Syria.
